- Speak somewhere private
- Be concerned for their safety & say so
- If they deny the abuse, express concern & state availability to talk in the future
- If they disclose the abuse, believe them and say so
- Tell them it's not their fault
- Respect their choices
- Don't confront their partner
- Tell them help is available
